## **2024 Residential Rebate Programs Summary**



## **Energy Waste Reduction (EWR) Program**

Holland BPW has had an Energy Waste Reduction (EWR) program for more than a decade. This program provides incentives to help customers <u>replace existing electric equipment</u> with more energy-efficient options.

Some examples of this program include buying ENERGY STAR appliances or buying a new air conditioner with a SEER2 rating above the federal minimum of 13.4. Recycling old appliances is also incentivized since it allows their potentially harmful refrigerants to be safely recycled.



## **Beneficial Electrification (BE) Program**

Holland BPW is now offering Beneficial Electrification (BE) rebates to help customers <u>replace</u> <u>existing fossil-fueled equipment</u>, e.g., gasoline or natural gas, with more efficient electric equipment under the following conditions:

- 1. The operating cost to the customer is expected to be the same or cheaper
- 2. There is an estimated net reduction in the carbon emissions impact of the switch

Unless a BE measure meets these criteria, it is not incentivized as part of our program. Examples of BE rebates include switching from a natural gas furnace to a heat pump or replacing a gasoline lawn mower with a battery-powered mower.



## **Holland Energy Fund Rebate Program**

For City of Holland residents who have completed the Home Energy 101 program, Holland Energy Fund (HEF) provides rebates for many of the same energy efficiency measures as HBPW. Residents can receive rebates up to \$6,000 per household for:

- Heat pump HVAC systems
- · Home air sealing & insulation projects
- · Heat pump water heaters
- · Whole-home energy audits

## **Federal Incentive Programs**

For example, heat pumps may earn tax credits of up to \$2,000 or may be worth up to \$8,000 in rebates depending on household income. To apply for any federal incentives, you will need to complete separate paperwork.

#### **Equipment Specifications and Documentation Requirements**

#### **GENERAL PROGRAM RULES**

This offer is valid only for Holland Board of Public Works residential electric customers for a limited time. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2024. Your completed application and the required documents must be received by December 31, 2024, or within 60 days of purchase/invoice, whichever is later. Holland Board of Public Works reserves the right to withdraw or change this offer without notice. Rebates will not exceed purchase price. Ineligible rebate requests are subject to denial or repayment to program. All equipment must be new and installed or operated in a residential dwelling where electric service is provided by Holland Board of Public Works. If you are unsure if you are eligible for a rebate, please call 616-355-1577.

To verify purchase, all applications must include: A copy of the invoice/receipt indicating the make, model, payment in full, and date of purchase. See below for specific requirements and/or documents that need to be included with this application based on equipment.

#### **EQUIPMENT SPECIFICATIONS**

**A/C Tune-Up:** A standard A/C tune-up is a cleaning and inspection of the indoor and outdoor coil which includes: cleaning or replacement of air filter, inspection and lubrication of blower, cleaning/inspection and lubrication of motors, checking/adjusting the refrigerant, confirmation of proper air flow, checking condensate drain, cleaning debris from and around condenser, and performing visual inspection of entire A/C system. Include a dated copy of the contractor's checklist. Limit 1 per customer per year.

Central Air Conditioning: Include the AHRI Certificate with this application to verify efficiency for SEER2 15.2 or 16+.

**HVAC Heat Pumps:** Heat pumps must be the primary method of heating and cooling the space. Heat pumps not rated cold climate need to have a HSPF2  $\geq$  7.5 and a SEER2  $\geq$  13.4. Cold climate heat pumps for non-ducted systems: HSPF2  $\geq$  8.4, SEER2  $\geq$  14.3, and COP  $\geq$  1.75 at 5°F. Cold climate heat pumps for ducted systems: HSPF2  $\geq$  7.7, SEER2  $\geq$  14.3, and COP  $\geq$  1.75 at 5°F. Include the <u>AHRI Certificate</u> with this application to verify efficiency for HSPF2 and SEER2. If applying for a cold climate heat pump rebate also include the <u>performance specs</u> showing the COP at 5°F. Rebates cannot exceed \$4,000. Customers purchasing a new furnace or other home heating system in addition to the heat pump are ineligible for the cold climate rebate.

ENERGY STAR Room Dehumidifier, Refrigerator, Pool Pump, Electric Clothes Dryer, Heat Pump Clothes Dryer, Clothes Washer, Dishwasher and Air Purifier: Provide proof of ENERGY STAR certification with this application. Refrigerator must be 10 cubic ft. or larger.



Induction Cooking Appliance: Ranges, cooktops, and single burner induction appliances are eligible.

**ENERGY STAR** Heat Pump Water Heater: Provide <u>proof of ENERGY STAR certification</u> with this application. Under the Energy Waste Reduction program, a \$200 rebate is available if an *electric resistance* water heater is being replaced. Under the Beneficial Electrification program, a \$300 rebate is available if a gas water heater is being replaced.

Programmable Thermostat: Must be installed in a home with central air conditioning to qualify.

Electric Lawn Tools: Holland BPW electric customers need to make a qualifying electric lawn tool purchase to receive the rebate. Any customer seeking the recycled tool rebate for a given tool must recycle an existing gas-powered tool of the same type (e.g., mower) and comply with the following. Drain the gas-powered lawn tool of all fluids and bring it to PADNOS Black River Recycling Center located at 11531 Chicago Drive, Holland, MI 49424. Ask for a Holland BPW recycling receipt and include it with this application. Residential customers must own the units being recycled. Limit one rebate (tool-only or tool-plus-recycle-bonus) for each type of electric tool per year.

**Panel Upgrade:** Up-size an existing service panel capacity to a minimum 200 amp service. Must include the addition of a level 2 EV charger or at least one 240 V appliance electrification (converted from natural gas). Work must be completed by a licensed electrician. A copy of the electrical permit must be included with this application along with proof of charger/appliance purchase. You will have 12 months from the time of the panel upgrade to install qualifying equipment to receive the panel rebate.

Your completed application and the required documents must be received by December 31, 2024, or within 60 days of purchase/invoice, whichever is later. Holland Energy Fund reserves the right to withdraw or change this offer without notice. HEF rebates may be combined with applicable Holland BPW Energy Smart rebates but will not exceed the purchase price of any given efficiency measure. Pre-approval with the City of Holland is recommended to ensure project eligibility, call 616-355-1355. Total cost of measure includes labor and material costs if installed by a licensed contractor. If you self-install the measure, you can only receive a rebate on the purchase price of the materials. Ineligible rebate requests are subject to denial or repayment to the Holland Energy Fund. All equipment must be new and installed or operated in a residential dwelling within the City of Holland. Insulation rebates are not applicable to new construction. To verify purchase, all applications must include: a copy of the invoice/receipt indicating the make/model, payment in full, and date of purchase. The City of Holland reserves the right to perform an inspection of the installation.

#### **EQUIPMENT/PROJECT SPECIFICATIONS**

**Heat Pump Water Heaters:** Provide proof of ENERGY STAR certification with this application. A \$200 rebate is available if an *electric resistance* water heater is being replaced, and a \$300 rebate is available if a gas water heater is being replaced.

**HVAC Heat Pumps:** Heat pumps must be the primary method of heating and cooling the space. Heat pumps not rated cold climate need to have a HSPF2  $\geq$  7.5 and a SEER2  $\geq$  13.4. Cold climate heat pumps for non-ducted systems: HSPF2  $\geq$  8.4, SEER2  $\geq$  14.3, and COP  $\geq$  1.75 at 5°F. Cold climate heat pumps for ducted systems: HSPF2  $\geq$  7.7, SEER2  $\geq$  14.3, and COP  $\geq$  1.75 at 5°F. Include the AHRI Certificate with this application to verify efficiency for HSPF2 and SEER2. If applying for a cold climate heat pump rebate also include the performance specs showing the COP at 5°F. Rebates cannot exceed \$4,000. Customers purchasing a new furnace or other home heating system in addition to the heat pump are ineligible for the cold climate rebate.

Air Sealing: Any project that is installed for the purpose of reducing air leaks in the applicant's home (not including new windows, storm windows, or other window inserts). Provide final receipt/invoice. Inspection by City staff may be requested.

**Insulation:** Any project that is installed for the purpose of adding insulation of the exterior building envelope of the applicant's home (basement, exterior walls, and/or attic). Provide final receipt/invoice. Inspection by City staff may be requested.

Whole Home Energy Audit: Provide final receipt/invoice and a copy of the final audit report clearly indicating date of audit, home address, contractor/company, and key findings of the audit.
